- 2. The system should have a file compression software to unzip excel utility file.
- 3. Make sure that you have downloaded the latest Excel Utility from BSE Website to you
- 4. Make sure that you have downloaded the Chrome Browser to view report generated fi
- 5. Please enable the Macros (if disabled) as per instructions given in manual, so that a

- **I. Fill up the data:** Navigate to each field of every section in the sheet to provide appli format. (Formats will get reflected while filling data.)
 - Use paste special command to paste data from other sheet.

- **II. Validating Sheets:** Click on the "Validate" button to ensure that the sheet has and also data has been furnished in proper format. If there are some errors on the shiprompt you about the same.

 - To view HTML Report open "Chrome Web Browser" .
 - To print report in PDF Format, Click on print button and save as PDF.
- **VI. Upload XML file to BSE Listing Center:** For uploading the XBRL/XML file general login to BSE Listing Center and upload generated xml file. On Upload screen prinformation and browse to select XML file and submit the XML.
