Parliament passes Bills to amend SC, ST lists in Andhra, Odisha

NEW DELHI, FEB 8 /--/ Parliament gave its nod to two bills which seek to modify the list of Scheduled Castes and Scheduled Tribes in Andhra Pradesh and Odisha, with Lok Sabha on Thursday passing it with voice vote.

The Constitution (Scheduled Tribes) Order (Amendment) Bill, 2024, and the Constitution (Scheduled Castes and Scheduled Tribes) Order (Amendment) Bill, 2024 were both passed by Rajya Sabha on Tuesday. The first bill seeks to modify the list of Scheduled Tribes in Andhra Pradesh while the second one seeks to modify the list of Scheduled Castes and Scheduled Tribes in Odisha. Replying to the debate on the bills, Minister of State for Tribal Affairs Bharti P Pawar said the Modi government has done a lot for the upliftment of tribal people including its effort to make aspirational district to inspirational one.

Moreover, the government has also launched schemes such as Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan to improve the socio-economic conditions of the Primitive Vulnerable Tribal Groups (PVTGs), she said. In Andhra Pradesh, three more ethnic groups — Bondo Porja, Khond Porja and Parangiperja — are being added to the list of STs. While in Odisha, it will add four groups in the list. All these are PVTGs and they have been added to the scheduled list after 75 years of Independence, she added.

During the debate, the opposition members urged the government to form a joint parliamentary committee to evaluate demands of various communities to be included in the list of Scheduled Tribes, saying piecemeal measures would not help. Initiating the debate, Saptagiri Sankar Ulaka of the Congress

welcomed the bill but pointed out that about 150 to 200 tribes have been added to the list of Scheduled Tribes in the past five years.

"There are around 12 crore Scheduled Tribes across the country. When we were in government, there used to be a procedure, where a JPC was constituted. MPs were part of it. They used to visit places, check the criteria and recommend who is ST and who is not," Ulaka said. "In the last four-five years, I think we have included almost 150 to 200 tribes in Scheduled Tribes. In Odisha, anyone who comes demanding ST status, the state government sends it to the central government. "They have sent around 180 tribes to be considered as ST. This naturally raises a concern if the demands are genuine or not," he

said, and added a JPC should look into the issue.

NCP MP (Sharad Pawar faction) Supriya Sule and Abdul Khaleque of the Congress also demanded that the Centre should form a JPC for meeting various communities that demand ST status and a comprehensive bill can be brought before Parliament. Saugata Roy of TMC meanwhile called for simplifying the process for communities to get ST status. Union minister Dharmendra Pradhan intervened in the debate and welcomed the bill. "This is important that this bill is coming at a time when a tribal woman is the president of India. The government is committed to protecting tribal people," he said. (PTI)

Security situation in Myanmar's Rakhine state worrisome: India

NEW DELHI, FEB 8 /--/ India on Thursday said the security situation in Myanmar's Rakhine state is "worrisome" and indicated its concerns over possible impact on the Indian consulate in Sittwe.

On Tuesday, India had asked all its citizens in the Rakhine state to leave the troubled region immediately in view of the deteriorating security situation. "The security situation in the Rakhine state is worrisome. We issued an advisory for our citizens to leave Rakhine and told those planning to travel not to go there," External Affairs Ministry Spokesperson Randhir Jaiswal said at his weekly media briefing. Jaiswal said he does not have information on the exact number of Indians living in Rakhine. "We have a

consulate in Sittwe. Security situation could have an impact on our consulate. We are looking at the situation and we will see how best to deal with it," he said. Union Home Minister Amit Shah on Thursday said the government decided to scrap the India-Myanmar Free Movement Regime (FMR). "It is Prime Minister Shri @narendramodi Ji's resolve to secure our borders. The Ministry of Home Affairs (MHA) has decided that the Free Movement Regime (FMR) between India and Myanmar be scrapped to ensure the internal security of the country and to maintain the demographic structure of India's North Eastern States bordering Myanmar," Shah said on X.

The announcement came two days after Shah said India has decided to

fence the entire 1,643-km-long India-Myanmar border. Jaiswal said the situation along the Myanmar border is serious but declined to comment further as he referred to Shah's remarks. Myanmar has been witnessing wide-spread violent protests demanding restoration of democracy since the military seized power in the coup on February 1, 2021. Rakhine state and many other regions have reported severe fighting between armed ethnic groups and the Myanmarese military since October last year.

The hostilities between the two sides saw a rapid spike since November in several key Myanmarese towns and regions near the border with India as well fuelling concerns in New Delhi over the possible ramifications for security of

Manipur and Mizoram. Myanmar is one of India's strategic neighbours and shares its border with a number of northeastern states including militancy-hit Nagaland and Manipur. Last week, India had called for complete cessation of violence in the country and its transition towards inclusive federal democracy.

To a question on general elections in Pakistan, Jaiswal refused to comment. On recent attacks on Indian students in the US, he said the attacker who killed Vivek Saini in Georgia has been arrested.

The local authorities are investigating the case, he said. Jaiswal said preliminary reports suggested that there was no foul play in the death of an Indian student in Cincinnati. (PTI)

Practice of 40% kickbacks continues under Cong gov: Karnataka contractors

BENGALURU, FEB 8 /--/ Karnataka State Contractors' Association president D Kempanna on Thursday alleged that the practice of 40 per cent kickbacks on government contracts continues even under the Congress regime. Accusing officials in the state government of rampant corruption, he said, earlier (during the previous BJP regime) public representatives were demanding bribes, now it's their turn.

"Corruption is on in Karnataka by the officials. Till now no MLA, MP or Minister has asked us for money. Earlier MLAs used to ask for a specified amount to give us a contract for work, that is not the situation now. Now the officials come

and ask -- give money, if you want work," Kempanna said. Speaking to reporters here, he said, "When we ask as to whom the money should be given, they (officials) say -- why do you want it (to know)? If you want the work, give money."

The Association had under the leadership of Kempanna earlier alleged "harassment" by ministers, elected representatives and others during the previous BJP regime, accusing them of demanding 40 per cent commission for awarding contracts and clearing bills, and had even written a letter to the Prime Minister Narendra Modi in this regard..

During the 2023 Assembly polls, the Congress had made the Association's charge a major

campaign issue to dub the BJP as being "corrupt". This was seen as one of the key factors that led to BJP's debacle in the elections.

Asked to reveal the identity of the officials who were demanding bribes, Kempanna said, "I'm already facing five defamation cases, so I don't want to reveal the names of the officials as of now.

Such officials are there in all the departments," he said. "(some) officials are very worst, they are corrupt officials, whether it is in BBMP (Bruhat Bengaluru Mahanagara Palike) or PWD (Public Works Department) or Irrigation department.

The arrogance of officials has reached its height, we are fighting against it." Asked how much commission is being

demanding now, Kempanna, who had levelled the 40 per cent kickbacks charge against the previous BJP government, said, "the same 40 per cent commission has continued, because of officials. If officials are not controlled, the government in no way will get a good name...officials seem to be controlling things," he added.

"Package system" is being followed to take up projects in all departments, Kempanna said. "This is being done with the intention to keep away local contractors and favour contractors from neighboring states. Due to the package system, local, small-medium contractors of the state are facing problems as they are not getting the work." (PTI)
