# Pakistan should focus on economy instead of harbouring terrorists and bombing its own people: India

GENEVA, SEPT 24 --/ India has said Pakistan should focus on building its economy and improving its human rights record instead of harbouring terrorists and bombing its own people, in an apparent reference to the killing of 24 people in an explosion in Khyber Pakhtunkhwa this week. Kshitij Tyagi, Counsellor at India's Permanent Mission in Geneva, also slammed the Pakistan delegation at the UN for abusing the forum with baseless and provocative statements against India. A delegation that epitomises the antithesis of this approach continues to abuse this forum with baseless and provocative statements against India, Tyagi said on Tuesday while speaking at the 60th regular session of the UNHRC here. Referring to Pakistan-occupied Kashmir, Tyagi asked Pakistan to vacate Indian territory under their illegal occupation. "Instead of coveting our territory, they would do well to vacate the Indian territory under their illegal occupation," he added.

Without specifically naming the Khyber Pakhtunkhwa incident, Tyagi said Pakistan should instead focus on building its economy and improving its human rights record once it finds time from harbouring terrorists and bombing their own people. Focus on rescuing an economy on life support, a polity muzzled by military dominance, and a human rights record stained by persecution perhaps once they find time away from exporting terrorism, harbouring UN-proscribed terrorists, and bombing their own people, Tyagi added.

Ten civilians and 14 militants were killed when bomb-making materials stored at a compound owned by the banned Tehreek-e-Taliban Pakistan (TTP) militant group exploded on Monday in Tirah Valley's Matur Dara area in Khyber district of the province, bordering Afghanistan. Imran Khan's Pakistan Tehreek-e-Insaf party's provincial branch and residents claimed that the "jet bombing" in the Tirah Valley caused the explosion. However, the local administration denied the claims about aerial strikes on the compound, saying the explosives used in bomb making exploded. (PTI)

# Trump played key role in ending hostilities between India, Pakistan: US Secretary Rubio

UNITED NATIONS, SEPT 24 --/ President Donald Trump was very involved in bringing about the cessation of hostilities in the very dangerous conflict between India and Pakistan, US Secretary of State Marco Rubio has claimed. Speaking at a United Nations Security Council Ministerial Meeting on Ukraine on Tuesday, Rubio said the US President had made restoring global peace one of his top priorities. When President Trump took office, he made it among his highest priorities the restoration of peace anywhere and everywhere in the world where the opportunity presented itself. And it's met with great success in a number of places. "We had a conflict between India and Pakistan, which was a very dangerous conflict, and one that the chose to engage in and was able to bring it to be very involved in bringing it to a cessation of hostilities," he said.

Rubio further said that Trump has played a critical role in resolving several other conflicts, including those between Thailand and Cambodia, the Congo and Rwanda, and Azerbaijan and Armenia. However, he said the ongoing war in Ukraine had proven to be an extraordinary challenge. The President has worked on it tirelessly, has invested a tremendous amount of his own time, energy, and the highest levels of our government, Rubio said, adding that meetings in Turkey, Saudi Arabia and Alaska, along with numerous phone calls, had all been aimed at ending the conflict. "This is a war that cannot end militarily. It will end at a negotiating table. That's where this war will end. But the longer it lasts, the more people will die, the more will be destroyed," he said.

Earlier, Trump reiterated his claim from the podium of the UN General Assembly that he had stopped the conflict between India and Pakistan, while criticising the United Nations for its failure to even try to help "in ending the conflicts. In a period of just seven months, I have ended seven unendable wars. They said they were unendable, you are never going to get them solved, Trump said during his address at the General Debate of the high-level 80th session of the UN General Assembly on Tuesday. Trump said some of the wars he helped end were going on for decades. He again claimed to have ended long-running conflicts, including those in Cambodia and Thailand, Kosovo and Serbia, the Congo and Rwanda, Pakistan and India, Israel and Iran, Egypt and Ethiopia, and Armenia and Azerbaijan. No president or prime minister, and for that matter, no other country has ever done anything like that. And did it in just seven months. It's never happened before. There's never been anything like that. (PTI)
