কলকাতা : আলিপুরদুয়ারের ৫ বছর বয়সী আর্ঘ সাহা (নাম পরিবর্তিত) বড় ফুসফুস সংক্রমণ থেকে সম্পূর্ণ সেরে উঠেছে মণিপাল হাসপাতাল, মুকুন্দপুরে। ভারতজুড়ে পরিচিত মণিপাল হাসপাতাল সংক্রমণ এই ইউনিটে আর্থর চিকিৎসা পরিচালনা করেন ডাঃ শুভাশিস সাহা, কনসাল্ট্যান্ট, পেডিয়াট্রিক সার্জন, এবং ডাঃ সায়ন্তন ভৌমিক, অ্যাসোসিয়েট কনসাল্ট্যান্ট। মণিপাল হাসপাতাল, মুকুন্দপুরে শিশুদের অসুস্থতা হ্রাস করা হয়। কিন্তু অসুস্থতার অবনতি ঘটলে তাকে মণিপাল হাসপাতাল, মুকুন্দপুরে আনতন্ত্রিত করা হয়। ভর্তি হওয়ার সময় তার শ্বাসযন্ত্র খুবই সংকটজনক অবস্থায় ছিল, কারণ সংক্রমিত তরল পদার্থ ডান দিকের ফুসফুসকে চেপে ধরেছিল, ফলে ঠিকঠাক শ্বাস নিতে পারছিল না। দ্রুত চিকিৎসা শুরু করে ডাক্তাররা সিস্টামেট নন আধুনিক ভিডিও অ্যাসিস্টেড থোরাস্কোপিক সার্জারি করার, যাতে সংক্রমিত পুঁজ বের করে ফুসফুস আবার স্বাভাবিকভাবে কাজ করতে পারে। আর অস্ত্রোপচারের পর আর্থরকে প্রায় ১০ দিন ভেন্টিলেটরে রাখা হয়, কারণ প্রথম দিকে ফুসফুস
